# CATHODE RAY TUBE (CRT) ANTITRUST DIRECT PURCHASER LITIGATION

MDL No. 1917, Case 3:07-cv-05944 U.S. District Court, Northern District of California, San Francisco

*Eligible purchase dates:* January 1, 1995 to November 25, 2007

## Case Description:

From at least March 1, 1995 through November 25, 2007, Plaintiffs allege that in order to maintain price stability, increase profitability, and decrease the erosion of pricing in the CRT market, defendants conspired, combined and contracted to fix, raise, maintain, and stabilize the price at which CRT products were sold in the United States.

Defendants are among the leading manufacturers of (a) color picture tubes (CPTs), which are cathode ray tubes (CRTs) used primarily in color televisions; (b) color display tubes (CDTs) which are CRTs used primarily in color computer monitors; and (c) electronic devices containing CPTs (such as televisions) or CDT's (such as computer monitors).

## Direct Purchaser Class:

All persons and entities who, between March 1, 1995 and November 25, 2007, directly purchased a CRT Product in the United States from any defendant or any subsidiary or affiliate thereof, or any co-conspirator. Excluded from the class are defendants; their parent companies, subsidiaries, and affiliates, any co-conspirators, all governmental entities, and any judges or justices assigned to hear any aspect of this action.

#### **Evaluation and analysis**:

In a recent Indirect purchaser settlement involving LCD Monitors and screens, claimants received over \$43 per screen. While past results may not be an indicator of future results, and this figure may have been an anomaly and not the norm, we do believe that these past CRT purchases are valuable, and that a substantial payment may be owed to eligible claimants in the CRT Direct Purchaser Settlement.

Pro-Rata Distribution to be based upon the purchase weighting of CRT products as follows:

- Cathode Ray Tubes at 100%
- CRT Computer Monitors at 75%
- CRT Televisions at 50%

As always, we recommend that claimants preserve any records pertaining to Product purchases that may be eligible. If you do not possess records that go back to the beginning of the eligible time frame, please contact us to discuss other means of supporting a claim for your qualifying purchases.
